From our Leadership



2023 has been a year of many accomplishments for Children's Hunger Alliance, allowing us to serve more children in need. I want to express my sincere appreciation to you for supporting the important work we do at CHA. This past year you helped us provide millions of meals to children across the state. We weathered

the pandemic, but these are still challenging times as the pandemic-era programs created to help those facing poverty are now expiring. For many children, too often there is no breakfast on their table when they get up in the morning and they go to bed hungry at night.

A lot of the work we do at Children's Hunger Alliance is focused on Federal Nutrition Programs – childcare centers, in-home childcare providers, afterschool programs and summer meals. We all know children are hungry seven days a week, and there aren't Federal Nutrition Programs to feed children on the weekend. That is why we launched our Weekend Meal Program, and I am happy to say that during the past year we were able to help more places around the state.

I came to CHA in 2016 and could not have imagined what the following years would bring, both from increased demand for our services and CHA's ability to respond. I am immensely proud of the work that CHA, along with partners and supporters, have done to provide our youngest and most vulnerable citizens with one of their most basic needs – food.

This is an exciting time for CHA, as Michelle Moskowitz Brown takes over as its next leader. Like you, I cannot wait to see how the organization will thrive under her leadership.

It has been an honor to be a steward of this great organization. I appreciate your continued support of Children's Hunger Alliance, which makes a difference in the lives of food-insecure children in Ohio.

Judy Mobley, Former President and CEO (2017-2023)



At the end of last year, I joined Children's Hunger Alliance as the eighth President and CEO. For the past 27 years I have served in not-for-profit leadership and management positions in food and arts-based organizations, and I believe in the power of our sector to affect meaningful change with government, business, and

community partners.

My personal experience with childhood food insecurity and my family's experience with diet-related disease fuel my work. Like each of our staff, board, supporters and partners, I have a commitment to serving children and families, and a belief that everyone should have the skills and resources to eat well. For the past 12 years, I served as the Executive Director at Local Matters (located in Columbus, OH) where I focused on growing organizational impact, increasing education and access to nutritious and affordable foods, and advocating for policies aligned with their mission of creating healthier communities.

In addition to my previous work, I am the immediate past chair of the Ohio Food Policy Network (OFPN), which I helped build as a statewide coalition dedicated to a food system that supports and serves all Ohioans. From 2014-2016, I co-led the creation of the first ever Columbus & Franklin County Local Food Plan, and served on its board for 7 years. These experiences have helped shape my understanding of barriers and opportunities to food access, and the critical importance of hands-on education from the youngest age possible, to support children's needs now and in the future.

Thank you to everyone for the warm welcome and stay tuned for how we will continue to strengthen Children's Hunger Alliance in service to children across the state of Ohio!

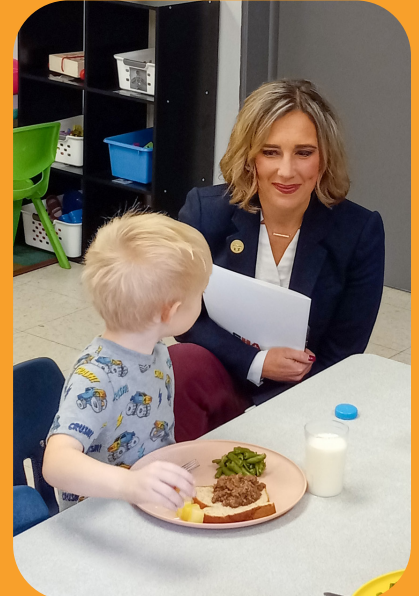

CHA Thanks Governor DeWine & Ohio Legislature for Investment to Tackle Childhood Hunger

Everyone at CHA sincerely appreciates Governor DeWine and the members of the Ohio Legislature for including a generous investment of \$7.5 million in the 2024-2025 state biennial budget for the important work of providing meals to children.

CHA will use the increased state operating funds to sustain and expand the ongoing work to feed food insecure children across Ohio. Over the last two years, CHA has increased its partnerships to meet the growing need for their services and has provided over 19 million meals to Ohio's children through our various programs. State funding will be especially helpful to address the growing need for weekend meals, which is not supported by any federal nutrition program.

"On behalf of Children's Hunger Alliance and the children that depend on the meals we provide, I sincerely thank Governor DeWine and members of the Ohio Legislature for prioritizing the food insecure children of Ohio with this funding," said Judy Mobley, Former President and CEO of Children's Hunger Alliance. "While we are one of the largest and most geographically diverse sponsors of the federal nutrition programs in Ohio, there are many more children that need our help and this funding will allow us to reach them."

Honoring the 2022 Programs of the Year

Rodriguez Childcare Center (Columbus) Childcare Center Program of the Year

Rodriguez Childcare Center has been a CHA partner for three years. They serve "home style" meals and encourage the children to try different foods. The resident cook serves well-balanced nutritious meals and snacks, including lots of fresh fruits and vegetables. The staff is very friendly and maintains a loving and nurturing environment for the children.



Sherri Congrove (Circleville) In-Home Childcare Provider of the Year

Sherri Congrove goes above and beyond for the children in her care. She shows love for children like no other, as displayed in the way her home has been set up to educate the kids. Many of the meals she makes are from scratch, which many of the children do not get at home. Ms. Congrove exhibits the characteristics and practices that CHA looks for in their partners.

Columbus Metropolitan Library (Columbus) Afterschool Program of the Year

Columbus Metropolitan Library has been a CHA partner since 2015. The library system provides meals each day at 15 branch libraries in conjunction with their Homework Help Centers. Last school year, they provided nearly 80,000 meals. In 2022, they began providing year-round food service with CHA as part of the Summer Food Service Sponsorship.



Perry County District Library (New Lexington) Summer Program of the Year

Perry County District Library has been an afterschool and summer CHA partner since 2019. There are six branches in their system, but only four branches qualify for the USDA Summer Food Service Program, so they began purchasing food on their own to meet the need of all children. The library administration has a commitment to providing food access to Perry County children.

Northwood Local Schools (Northwood) School Breakfast Program of the Year

Northwood Local Schools wants to make sure that no student begins their day hungry. With a No Kid Hungry grant, facilitated by CHA, they started a breakfast in the classroom program allowing all students to start their day ready to learn. Approximately 600 students in Kindergarten to 12th grade eat breakfast at school where they have a choice of a variety of items. They operate a grab-and-go model for breakfast, which has helped to increase participation.



Mansfield City Schools (Mansfield) Weekend Meals Program of the Year

As part of the Adopt-A-School expansion, Mansfield City Schools is able to provide weekend meal boxes to all students at Sherman Elementary. The boxes are provided weekly, and contain elements to sustain children through the weekend. These are a great supplement for those living in food insecure households.

Menu of Hope Returned to In-Person for 2023



The 28th annual Menu of Hope luncheon returned to in-person on March 1, 2023, and raised nearly \$500,000 to help provide meals to Ohio's hungry children. The theme of the event was how the power of one person can make a difference in the lives of many children in our communities.

The featured speaker Lauren Bush Lauren, Founder and Chairman of FEED, discussed how seeing hunger first-hand led her to create a social enterprise business dedicated to feeding hungry children. Her life experiences influenced her decision to get involved and make a difference to help those in need. She also touched on how supporting and advocating for meal programs have such a major impact on improving the lives of children.

American Electric Power and The American Electric Power Foundation have been strong supporters of Children's Hunger Alliance for several decades, and were honored with the inaugural Community Impact Award. They have not only been the presenting sponsor of the Menu of Hope luncheon for many years, but also the first funder in 2020, to make a multi-year gift to support CHA's programmatic work. They are a great example of how one organization's commitment to helping those in need can make a major impact on so many children.

Lima Reception



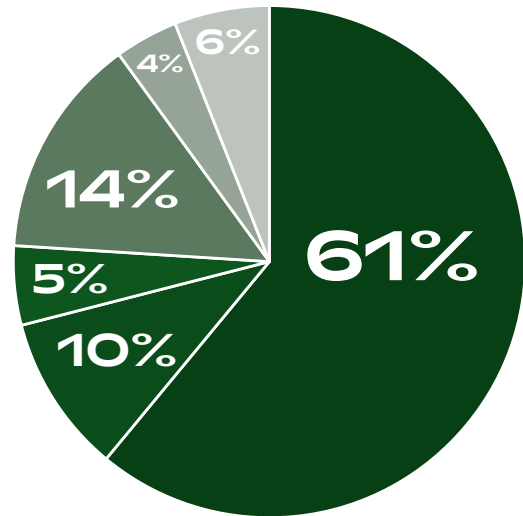

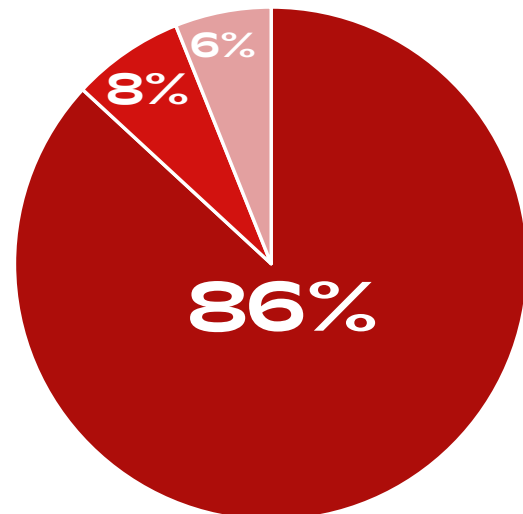

Program & Donor Impact

Expanded partnership with Nationwide Children's Hospital

For many years Children's Hunger Alliance has been working to provide meals to children in school, afterschool and childcare settings, but more recently we have been partnering with healthcare providers to distribute meals. Food insecurity is a social determinant of health, and can have a major impact on a child's ability to thrive.

In 2020, the staff at Nationwide Children's Hospital's Primary Care Clinic (located in Columbus, OH) reached out to CHA for assistance with addressing an issue they began noticing among children who came to the main campus for potential health issues – an increase in those presenting with symptoms of hunger in addition to the medical issue. As we now know, the COVID-19 pandemic caused the rate of childhood hunger to increase as many children lost access to the meals and snacks provided while receiving care at an in-home childcare provider, childcare center, a school's breakfast and lunch program, or from an afterschool program. Additionally, many families experienced an unexpected drop in household income affecting their ability to buy food. After receiving this request for assistance, CHA began providing ready-to-eat meals to Nationwide Children's Hospital at no cost to them. This allowed the hospital staff to provide one meal box per child, and to any siblings, when a child shows signs of food insecurity. The outcome for this program has been improved child nutrition in greater Columbus.

The meal boxes contain ready-to-eat meals that meet children's nutritional needs by providing a serving of protein, a whole-grain serving, a serving of fruit, and a serving of vegetables. The meals boxes can be taken home by the child without them needing to depend on an available adult for proper handling or refrigeration. Even more importantly, this food can be consumed by the child without relying on a responsible adult for cutting, peeling, or other preparation. Our agency had initially absorbed the costs of providing these meals, but in June 2021, a local foundation provided a \$10,000 grant to help fund this project.

Since this point other foundation funders, corporate partners and donors, such as Worthington Industries and the Harry C. Moores Foundation, have invested in the program so that CHA can expand from just the main Nationwide Children's Hospital to several of their clinics throughout Columbus and Dayton. Also in stories shared to us from our partner clinics, families in at-risk areas are coming to clinics without an appointment just to request food, because this important nutrition is needed by their children.

Food insecurity is a healthcare crisis seen throughout the entire state of Ohio, and Children's Hunger Alliance would like to continue and grow our partnerships with healthcare agencies to address this issue. This program has been so successful there is now a waiting list of additional clinics that want to participate, but additional investors and partners are needed. CHA hopes that other partners will join with us in the fight against childhood food insecurity, while growing important healthcare opportunities.

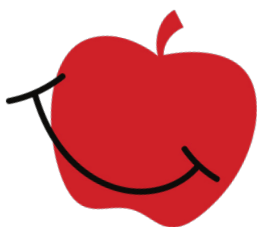
